Could you please explain the reason for requesting only 140 VUL licences?	The Log file may show up to 295 VMs. However, not all the VMs are protected by backup. The Commission doesn't immediately need licenses for all VMs. However, we have amended the numbers in the Terms of Reference (TOR). TERMS OF REFERENCE

Veeam subscription licenses for Microsoft 365 and support services for Veeam Backup and Replication

1. INTRODUCTION

The Preparatory Commission for the Comprehensive Nuclear-Test-Ban Treaty Organization (hereinafter referred to as the "Commission") is the international organization setting up the global verification system foreseen under the Comprehensive Nuclear-Test-Ban Treaty (CTBT), which is the Treaty banning any nuclear weapon test explosion or any other nuclear explosion. The Treaty provides for a global verification regime, including a network of 337 stations worldwide, a communications system, an International Data Center and on-site inspections to monitor compliance. The Headquarter and the International Data Center (CTBTO) of the Preparatory Commission are in Vienna (Vienna International Center of United Nations). The commission currently uses Veeam products for data protection, Infrastructure monitoring and analytics, and wishes to renew:

- Licenses for Veeam Backup for Microsoft 365, and Agent instances
- Support services for Veeam availability suite

2. DELIVERABLES

The Contractor shall provide the following:

2.1. Veeam Backup for Microsoft 365

- Subscription for 3 years, including Production 24x7 support from Veeam
- Required number of Microsoft 365 licenses: 550, out of which 500 are for renewal and 50 are new licenses.

2.2. Veeam availability suite (Backup and Replication, Veeam One)

The contractor shall offer 2 options for the renewal. After analysis, the Commission will order the most appropriate option:

Option 1: renewal as is, without migration

- 3-year support renewal of the existing 28 sockets perpetual license
- 3-year subscription renewal for 10 Veeam Agents

Option 2: renewal with migration to Universal Licenses

- Migration of the existing 28 socket perpetual licenses to Veeam Universal Licenses (VUL)
- 3-year support for a pack of 140 160 VUL

2.3. Professional Services

- For each year of the Contract, the Commission shall have the option to exercise in a form of call-off up to 20 person/days with the Contractor.

The person/days shall be usable for consulting (including hands-on configurations) or Veeam accredited trainings

Note: Veeam provides discounted public sector pricing. In that regard, the Contractor shall confirm to the Commission that the offered price has considered the status of the Commission as an International Organization.

2.4 Optional VUL licenses

The Contractor shall offer the Commission the option to procure up to 150 additional VUL in a form of call-off during the 3 years support time.

3. CONTRACTORS QUALIFICATION

The Contractor shall be Veeam Silver Value Added Reseller. Contractor shall provide evidence of partnership with Veeam.
