1	Is it acceptable a proposal to recreate the full module if deemed to be more cost effective?	The proposal shall respond to the requirements specified in Term of Reference
2	Is there any template for submitting the financial proposal?	There is no fix template. The quotation shall allow to clearly understand the applicable costs and the total price.
		Please refer to the "Instructions to Bidders" and to the relevant requirements:
		The price quotation shall include the <u>total firm</u> <u>fix price</u> for the Services.
		Please use the attached "Sample of Price Schedule" for reference.  The price quotation shall include costs and expenses incurred by the Supplier for the full and proper performance of all obligations under the purchase order (including travel, allowances, management and remuneration of the personnel, national income tax, medical, insurance and social security contribution, if applicable).
3	Are the technical and the financial proposal required to be submitted separately or can be submitted together?	They can be submitted together. Kindly ensure that it is clearly specified the technical part and the financial part including applicable fees, costs and total price. Please do not include costs information in the technical description, as this might complicate the evaluation process.
4	The contracting authority requires that the bidder includes documentary evidence of its financial, technical and production capability as part of the bid. Which kind of documentation is required?	There is no fix requirement. Bidders are invited to provide sufficient information to establish their capability to perform the work.
5	Please clarify what is expected from bidders concerning the insurance provision of the RFQ	Kindly refer to the Annex A – General Condition of Contract – Clause 9
6	Do you require a bank guarantee for the work?	No bank guarantee is required.
7	Please clarify the Technical Evaluation Criteria and Method listed in Attachment 1 of the RQF. It is unclear what requirements are linked to the Contractor and which are directly linked to Contractors staff.	Kindly consult Section 7 in the Terms of Reference for the requirements that the Contractor must meet to be eligible for the project. The Contractor is expected to demonstrate the capacity to meet these requirements either internally or by engaging third parties.
8	What kind of references to previous similar projects should be provided?	Bidders are expected to provide a list of previous projects, with company names and web site links (if available) for review.
9	Do you require a quote only for section 4.1 of the Terms of Reference, and then a second quote for when the work will be defined?	No. The quotation shall cover the entire work as described in the Annex B -Terms of References.
