In Section 5 (Experience), it is stated that the Contractor "must have proven experience with similar road repair in the affected area." Kindly clarify if this statement excludes companies other than that/those who previously repaired the road in 2012 and 2018 (as stated in Terms of Reference) from successfully being awarded a contract to perform the work described in the Terms of Reference.

the Terms of Reference. Experience with similar road repair works in the affected area is required. In case a bidder does not have experience with this exact road repair and maintenance, the bidder must provide evidence of having experience with similar road repair within the same region of Palau. The evidence must clearly show that the bidder has experience with a project including the combination of removing weed/bushes, work on the road repair including layout/distribution of large aggregates, pavement of roads on steep hills and with deep trenches along the roads and water ditches crossing the roads. The bidder must also provide evidence that they have the adequate machinery for the work.

The experience must be from projects with all these conditions and repairs combined. Individual projects with removing weed/bushes or partial road repairs will not be accepted as adequate experience. The experience must be shown in form of a completed project report. The report must describe and show the similar road conditions before the work, during and after the completion of the work, in order for the
